# GRYPHON CAPITAL INCOME TRUST (ASX:GCI) ANNOUNCES CLOSE OF ENTITLEMENT OFFER

On 29 January 2024, One Managed Investment Funds Limited ABN 47 117 400 987 AFSL 297042 (**Responsible Entity**), the responsible entity for the Gryphon Capital Income Trust ARSN 623 308 850 (ASX:GCI) (**Trust**), announced a pro rata non-renounceable entitlement offer to Eligible Unitholders of 1 new fully paid ordinary unit in the Trust (**New Units**) for every 5 existing units held at 7.00pm (AEDT) on the Record Date (**Entitlement Offer**), together with an offer to new investors of any New Units not subscribed for under the Entitlement Offer (**Shortfall Offer**) to raise up to \$97.3million (**Offer**).

The Entitlement Offer opened on 8 February 2024 and closed on 23 February 2024.

The Responsible Entity will notify the ASX of the outcome of the Entitlement Offer on 28 February 2024 and the outcome of the Shortfall Offer on 5 March 2024.

### **Further Information**

The Entitlement Offer was made in accordance with section 1012DAA of the Corporations Act. For the purpose of section 1012DAA(f) of the Corporations Act, a Cleansing Notice in regards to the Entitlement Offer was lodged with ASX on 29 January 2024.

The Responsible Entity also issued a product disclosure statement in respect of the Offer to new investors, dated 29 January 2024 (**PDS**). The PDS contains important information relating to the Offer and should be read in its entirety before making a decision to invest in New Units.
