BirdDog is permitted to buy back up to 10% of its issued capital in any 12-month period, without shareholder approval under the Corporations Act. BirdDog currently intends to buy-back its Ordinary Shares up to a maximum of AUD \$2,000,000 under the proposed buy-back, that shall commence on or after 14 December 2022.



Part 5 - Final buy-back notification
