Appointment of Fiona Hele as Chair of the Board

Kelsian Group Limited (ASX:KLS) ('**Kelsian**') today advises that it has appointed Independent Non-Executive Director Fiona Hele to the role of Chair of the Board with effect from 1 July 2024. Fiona joined the Board in September 2016 and was appointed Deputy Chair in August 2022. Fiona has been Chair of the Company's Audit, Risk and Sustainability Committee since joining in 2016, and is also currently a member of the People, Culture & Remuneration Committee.

The appointment of Fiona as Chair follows the announcement in September 2023 that Kelsian's existing Chair of the Board, Jeff Ellison, would retire during his current term on completion of an orderly succession plan. With Fiona's appointment to the role of Board Chair, Jeff will retire and step down from the Kelsian Board on 1 July 2024.

"Since I joined Kelsian over 30 years ago, I am very proud of the significant growth that we have achieved, and I take this opportunity to thank my fellow Directors as well as the Executive team for their support and guidance," he said.
