GRANT OF ASX WAIVER

Centrex Limited (ASX: CXM) ("Centrex" or the "Company") is pleased to advise that, as contemplated in the Notice of Meeting dated 13 February 2024, ASX Limited ("ASX") has granted a waiver from ASX Listing Rule 7.3.9 to permit Resolution 4 in the Notice of General Meeting (Approval to issue SPP Shares and SPP Options) not to include a voting exclusion statement that excludes the votes of any person who may participate in the Share Purchase Plan ("SPP").

The approval was granted on the condition that the SPP is not underwritten, or if it is underwritten, the Company excludes any votes cast in favour of that resolution by any proposed underwriter or sub-underwriter of the SPP. The Company notes that the SPP is not underwritten and accordingly no shareholders will be excluded from voting.

The Company noted in its Notice of General Meeting dated 13 February 2024, that it was seeking the waiver from ASX Listing Rule 7.3.9 and that it would advise the ASX of the outcome of the decision once received.

With this decision of the ASX, participants in the SPP will now be permitted to vote on Resolution 4 in the Notice of General Meeting to approve the issue of the securities under the SPP, and the Company encourages Shareholders to complete and submit their votes prior to the meeting to be held on **Thursday 14 March 2024**.

The Company also takes this opportunity to remind eligible shareholders that the SPP is scheduled to close at 5pm (AEDT) on **Friday 15 March 2024.**
