FOREIGN INVESTMENT REVIEW BOARD APPROVAL RECEIVED

Lithium Power International Limited (ASX: LPI) ("LPI" or the "Company") refers to the proposed scheme of arrangement pursuant to which a wholly-owned subsidiary of Corporación Nacional del Cobre de Chile ("Codelco"), Salar de Maricunga SpA, will acquire 100% of the share capital of LPI ("Scheme").

LPI is pleased to announce that yesterday, on 3 March 2024, Codelco received written confirmation from the Foreign Investment Review Board ("FIRB") that the Commonwealth Government has no objection under the *Foreign Acquisitions and Takeovers Act 1975* (Cth) to the acquisition under the Scheme.

Accordingly, the condition precedent to the Scheme relating to FIRB approval, as set out in item 1, clause 3.2 of the Scheme Implementation Deed between LPI and Codelco dated 18 October 2023, has been satisfied.

The Scheme remains subject to certain other conditions precedent as previously announced, including approval of the Scheme by the Federal Court of Australia.
