**Non-Renounceable Rights Issue Update**

Zoono Group Limited (**Company**) (ASX: ZNO) advises that, while it is still committed to undertaking a non-renounceable rights issue for shareholders at \$0.027 per share, it has delayed the commencement of the issue again by several weeks due to external circumstances.

The non-renounceable rights issue offers all Eligible Shareholders the opportunity to subscribe for further Shares in the Company at the same price as offered in the December Placement though a pro-rata, non-renounceable rights issue of one (1) new Share for every two (2) existing Shares held by Eligible Shareholder on the Record Date at an issue price of \$0.027 per Share, to raise up to \$2.9M (before costs) (**Offer**). While the use of the funds raised from the Offer will be described in more detail in the Offer Document, the primary use of the funds will be to retire existing related party debt and to fund several company initiatives planned for 2024, including the supermarket shelf-life extension project (which is nearing completion), expansion into India and China, and further penetration into the USA market after gaining the List N registration (in line with previous announcements made by the Company).

Shareholders with a registered address in Australia or New Zealand (**Eligible Shareholders**) who hold ordinary shares in the Company at 7.00pm (AEDT) on 10 April 2024 (**Record Date**), will be able to participate in the Offer. It is the intention of the Managing Director (and major shareholder), Mr Paul Hyslop, and the other Directors to take up their full entitlements. Shareholders will also have the opportunity to apply for any unplaced shares (**Shortfall**) before the Offer is closed.
