This close period arrangement is not applicable for Betashares Active Australian Hybrids Fund (managed fund).

To be eligible, you will need to have purchased your units prior to the Ex Distribution Date, for the transaction to have been settled and for your unitholding to have been entered on the register as of the Record Date.

Any DRP elections made by eligible investors must be received by the registrar, Link Market Services, by 5pm AEDT on 04 April 2024.
