These Performance Rights relate to the 2022 Deferred Equity Award (DEA) as referred to in the Appendix 3G dated 02/09/2022 and are issued to correct an exchange rate calculation error in the number of rights issued to Mr O'Brien. Following a reconciliation of its rights, AAC became aware that, at the time of correcting this error, an Appendix 3G was not lodged and has been filed as soon as practicable upon become aware.

Consistent with the Appendix 3G dated 02/09/2022, the additional rights issued under the 2022 DEA will vest as follows:

- (i) 50% will vest on the date that is 2 years after 26/08/2022, subject to satisfaction of service conditions; and
- (ii) the remaining 50% will vest on the date that is 3 years after 26/08/2022, subject to satisfaction of service conditions.
