Appendix 4C – Quarterly Cash Flow and Activities Report

East 33 Limited (ASX:E33) ("East 33" or "Company") is pleased to provide the following the Appendix 4C, Quarterly Cash flow and Activities Report.

Revised Facility Agreement

The CEO completed a strategic review of the business' strategy and go-forward position, as per the ASX announcement issued 29 February 2024. Along with identifying new initiatives to improve business profitability and growth, the review also noted that East 33 will likely require a waiver from Yumbah Finance Pty Ltd (Yumbah Finance) of the interest cover covenant and the impairment charges financial covenant for the 12 month period ending 30 June 2024 (Financial Covenants) along with additional capital in the amount of \$5.0 million in order to repay the short term debt outlined in the ASX announcement noted above, subject to shareholder approval. This will also allow East 33 to maintain its overall debt position, continue its business operations, deliver the outcomes of the strategic review, and improve East 33's position in the market.

Corporate

During the quarter the business focused on aligning internal collaboration to achieve favourable performance outcomes and more clarity in forward-looking financial planning. Forward cash position remains strictly managed and the business is positioning itself to activate management's plans set out in the strategic review. Core to the future cashflows of the business is the outcome of the General Meeting to be held on 23 April 2024, as announced in the ASX announcement issued on 22 March 2024. The business maintained a strong trading position during the period driven by performance of the Distribution business supported by farming supply.

Operational - Distribution (CMB)

Following the favourable trading results through the Christmas period, CMB continued to focus on maintaining favourable margins on oyster sales. Despite the volumes of oysters sold through the distribution business being below the previous year, gross earnings exceeded targets as a more focused approach was taken to commercial activities. Oyster supply within the industry through the period returned to a relatively normal state from the previous quarter. This allowed CMB to focus on strategic purchasing activities which underpinned the gross earnings result.

CMB's financial results were also supported through a diversified earnings strategy. New commercial arrangements to increase the CMB facility utilisation were activated, increasing the earnings of the business unit.

Operationally, CMB continued to focus on operational excellence, through diligent management, QA and food safety processes. These processes were recognised through a 3rd party SQF Food Safety Audit, during the period which delivered a 99% compliant audit report.

Farming

Following the oyster maturation and condition challenges, compounded with the closure of Wallis Lake, discussed in the previous quarter, the farming business was able to materially increase its supply of stock to the market. Harvests increased across the business' Port Stephens and Wallis Lake farms, delivering against healthy demand for oysters observed in the market. Notably, the exceptional condition of our harvested stock across both locations provides management with added confidence regarding the future trajectory of our harvest volumes and the extended seasonal windows ahead.

In addition to a strong harvest and off-farm sales focus, the business also increased its activities relating to the improvement of the forecast harvest profile. Through strategic stock development opportunities, the farming network was able to materially

increase on-farm biological value in support of future harvest volumes. Ultimately, this will increase the stock available for future harvests and improve the overall margins across the East 33 vertically integrated supply chain.

Central the success of the consolidation of the farming business' stock will be the growth and quality outcomes of new juvenile oysters entering the systems. Conditions for young oysters were challenging through the period leading to variability in the onfarm biomass of oyster spat. Monitoring and mitigating these challenges is a core focus of the business going forward.

Forward Looking

Following the conclusion of the strategic review, the business has now shifted to implementing a number of the operational programs required to underpin future success. These include the stabilisation of our on-farm stock volumes, development of infrastructure and further integration across our vertically integrated supply chain. These initiatives will be built out as management develops a detailed view on the upcoming financial year through the budgeting process.

Core to the long-term aspirations of the business is increasing the capability within the senior leadership team and unlocking additional value within the business. This will be completed against the backdrop of strict working capital management.

Major cashflow movements

East 33's major cashflow movements for the quarter included:

- Receipt from customers \$6.5m;
- Product manufacturing and operating costs \$4m;
- Staff costs \$2.5m;
- Proceeds from borrowings \$5.5m; and
- Repayment of borrowings \$6.1m.

Payments to related parties

As detailed in item 6.1 of the Appendix 4C, payments to related parties of East 33 and their associates during the quarter were \$90,188 compromising Director fees.

7.1 Loan facilities total of \$20.5 million, made up of the Yumbah Finance Pty Ltd ("Yumbah Finance") loan facility totalling \$15 million includes \$5 million which is yet to be drawn down as it is subject to discussion and agreement with Yumbah Finance and was therefore excluded from the total facility available (only \$10.0 million shown above). Refer to details in 8.6.2 regarding a recapitalisation and funding plan with Yumbah Finance that is currently subject to shareholder approval in April 2024.

The Yumbah Loan Facility expiring September 2028 is fully secured against all assets in the East 33 Group. The annual interest of 5% + BBSY (bid) is capitalised for the first year, thereafter becoming payable quarterly in arrears.

Also included in the total facility in 7.1 is a short-term debt facility of \$5.5 million dollars ("**Short Term Facility**") with Anthony Rupnik, Tom Rupnik, Stephen Verdich and a controlled entity.

The Short Term Facility is unsecured and carries an interest rate of BBSY plus 5.0% per annum, payable up front in the aggregate amount of \$140,227 and is repayable on by 30 April 2024.

 - 8.6.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: Entity is expected to generate negative cashflows in the short term due to the operating costs exceeding expected earnings. As disclosed in the ASX announcement dated 14 February 2024 this arose as a result of forecast challenges with the maturation rate of our oyster stock.

- 8.6.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?
- Answer: Yes. A recapitalisation and funding plan with Yumbah Finance is currently subject to shareholder approval in April.
- Subject to shareholder approval, the Recapitalisation documents allow for a variation to the facility agreement with Yumbah Finance whereby East 33 will have access to additional debt funding. This is to be facilitated by way of:
- the conversion of \$5.0 million of the Face Value of the Convertible Note (Convertible Note Conversion) into Shares (Conversion Shares (Tranche 1)), with such number of Conversion Shares (Tranche 1) being determined by dividing the \$5.0 million of the Face Value (Conversion Amount (Tranche 1) by the Conversion Price.
- The \$5.0 million will be deemed to be paid by Yumbah Finance in reduction of the amount owing by East 33 under the Facility Agreement, which has a total Facility Limit of \$15.0 million plus capitalised interest and has \$10.0 million drawn down, so bringing the amount owing under the Facility Agreement to \$5.0 million plus capitalised interest; and
- following the Convertible Note Conversion, allowing East 33 to maintain the Facility Limit under the Facility Agreement at \$15.0 million plus capitalised interest, meaning that, with the Loan Facility paid down by \$5.0 million, East 33 will have a further \$10.0 million that can be drawn under the Facility Agreement

Answer: Yes. Subject to shareholder approval the recapitalisation will create sufficient working capital for the business to continue its operations based on management forecasts.
