Mayur Resources Limited – Request For Trading Halt

Mayur Resources Limited (Mayur; ASX : MRL) requests that an immediate trading halt be granted by the ASX with respect to its securities.

In accordance with ASX Listing Rule 17.1, Mayur provides the following information:

1. The trading halt is requested by Mayur pending an announcement in relation to the financing of the Central Lime Project;
2. Mayur expects to be able to release this announcement later today;
3. Mayur requests that the trading halt remain in place until the earlier of an announcement to the market in relation to the financing, or in the event of any delays beyond this expected timing no later than the commencement of trading on Tuesday, 23 April 2024; and
