#### Late lodgement of Appendix 3Z

Terragen Holdings Limited (Company) has identified the late lodgement of Appendix 3Z for Mr Sam Brougham who ceased to be a Director of the Company on 6 April 2024. The Company provides the following information regarding the late lodgement:

- 1. The delay in lodgement of the Appendix 3Z was due to an internal administrative oversight rather than a systematic problem with the Company's existing share trading policies and procedures. Upon becoming aware of the oversight in failing to lodge the Appendix 3Z, the Company lodged the Appendix 3Z with ASX on 23 April 2024.
- 2. The Company has a Disclosure and Communications policy which mandates the disclosure of its Directors' declarations. Unfortunately, an internal administrative oversight arose which delayed the disclosure of the Notice.
- 3. The Company has reviewed its processes and will ensure that disclosures are released to the ASX in accordance with the timing requirements of the ASX listing rules in the future.
