## NewPeak completes Share Placement

NewPeak Metals Ltd (ASX:NPM) (NewPeak or the Company) is pleased to announce that it has placed 13.667 million shares at 1.5 cents to raise \$205,000 cash to a new cornerstone investor, Mr. Gerhard Redelinghuys, founder of Bowen Coking Coal Ltd, Queensland. This is a part of the Placement announced to the ASX on 15 April 2024, being the total amount of stock the Company has available for placing at this time

A subscription for a further 6.333 million shares at the same price (\$95,000) has been agreed to by Mr. Redelinghuys, which will be placed as a part of the total intended \$500,000 Placement, subject to approval at the Company's planned EGM in late May 2024. The Company expects to have binding commitments to the remainder of the Placement shortly.

NewPeak will also undertake a Rights Issue to raise not less than \$500,000 at the same issue price as the Placement shares.

The funds shall supplement the Company's existing and future cash resources from its recent and future asset sales and be used to carry out intended exploration activities on the Canadian properties (ASX release 15 April 2024), once that transaction closes, and be available for new acquisitions and general working capital.

Gerhard Redelinghuys founded Bowen Coking Coal Ltd and steered the company from a small exploration company to a multi-mine producer listed in the ASX 300. Gerhard has 30 years' experience in financial and project development within the mining sector, including Managing Director roles at EXXARO Australia and Cape Coal. In addition to his business analysis experience, Mr Redelinghuys has extensive experience in mining project acquisitions, joint ventures and deal making on an international level.
