QUARTERLY ACTIVITIES REPORT

Aeon Metals Limited (ASX:AML) (**Aeon** or the **Company**) is pleased to present its activities report for the quarter ending 31 March 2024.

Highlights:

- Discussions with Waanyi People in relation to new Cultural Heritage and Monitoring Agreement nearing completion.
- Search for potential partners in Walford Creek Project continues.
- Evaluation of new project opportunities on-going.
- Managing Director, Dr. Fred Hess, will revert to a non-executive director, effective 1 May 2024.

Commenting on the activities for the quarter, Aeon Managing Director, Dr Fred Hess, said:

"The Company was looking forward to announcing the completion of discussions with Waanyi People resulting in a new Cultural Heritage and Monitoring Agreement (CHMA). This process was on track for mid-April but has been postponed until mid-May.

"The Waanyi PBC which is effectively the lead counterparty in our negotiations with the Waanyi People had a Special Administrator appointed in early April. The Special Administrator made immediate changes to the Wannyi PBC and under these circumstances he considered it inappropriate to proceed with a community meeting to discuss the new CHMA that was scheduled for later that same week.

"Following a meeting with the Special Administrator, the company is confident that the new CHMA can be approved by the Waanyi community at the postponed meeting now scheduled for mid-May. The resolution of this matter at this time would mean that exploration activities for the full 2024 dry season could be undertaken again after a one-year hiatus.

'The Company is currently finalising an update to the market of the results of a recently completed internal geological review of the prospectivity of its tenement holdings outside of the Walford Creek Project targeting a number of commodities."






Aeon - Mount Isa Region location map




