Net Asset Value as at 10 May 2024

The weekly estimated unaudited net asset value (NAV) before withholding tax as at 10 May 2024 was \$0.65* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 10 May 2024 would be \$0.58* per unit.

Calculation of weekly NAV

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited fully diluted monthly NAV at 30 April 2024 (being \$0.67 per unit on a pre-tax basis and \$0.60 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.6473) and adjusting for changes in the AUD:USD foreign exchange rate.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 10 May 2024 was 0.6604.

These weekly estimates do not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.
