

DEVELOPMENT ENGINEERING UPDATE

13 June **2024**: Quickstep Holdings Ltd (ASX: QHL) (Quickstep or the Company) is pleased to provide an update on several significant new business developments.

- A follow-on order for 20 Volanti aircraft, valued at approximately \$430,000 has been received. This
 is in addition to the \$1.35 million 40 unit order previously announced in March, which was delivered
 complete in early June. Amongst much customer interest, the Company and its partners have also
 received a request from a foreign military customer to undertake overseas trials of the Volanti
 aircraft in this build configuration.
- The previously announced \$500,000 work statement in support of TB2 Aerospace LLC will be completed prior to June 30th and an additional follow-on contract, initial value \$300,000 for engineering design services, has been received.

Following the recent delivery of the 100th series production drone from Geelong, and ongoing demand for Quickstep's engineering services, the Company sees continued expansion in both the drone aerostructures and payloads business into FY25.

The Company is also delighted to announce the finalisation of a \$925,000 space grant from the Commonwealth Department of Science, Industry & Resources (DSIR) under the Moon to Mars initiative,

As part of an overall \$1.3 million development program, this DSIR grant will fund the acquisition of a large-scale CNC router/3D printer for use in rapid prototyping and low-rate initial production of complex composite structures in the domestic and international space segment. It will also support AeroQureTM high-rate production tooling for use in emerging space applications and drones, as well as the in-house manufacture of production tooling across all program areas.

The new equipment will be installed into an expanded engineering and production facility at the Company's Geelong, VIC site. With a concurrent move into newly leased premises at the same location, a threefold increase in production floor space will enable the delivery of increased production volumes.
