# US Masters Residential Property Fund (ASX: URF) – Admission of US Masters Residential Property Fund II and Quotation of Stapled Securities

# **Description**

US Masters Residential Property Fund ('URF') ('Trust') is currently admitted to the Official List of ASX and its fully paid ordinary units trade under the ASX Code URF.

On 20 June 2024, unitholders in URF approved the resolutions necessary to staple the fully paid ordinary units of US Masters Residential Property Fund II ('New Trust') to the fully paid ordinary units in the Trust ('Stapling Proposal').

The Stapling Proposal will be achieved by the New Trust issuing to unitholders of the Trust one New Trust unit for each Trust unit held, so that the units become stapled on a one-for-one basis forming a single class of stapled securities ('Stapled Securities'). The issue will occur under the meeting booklet dated 14 May 2024 by way of an in-specie distribution being made to URF unitholders, who under the Trust's and New Trust's constitutions, authorise and direct US Masters Responsible Entity Limited, as responsible entity of both the Trust and the New Trust, to make the in-specie distribution of the units in the New Trust to unitholders of the Trust.

The New Trust was admitted to the Official List of ASX on Thursday, 20 June 2024. The new stapled entity will trade as US Masters Residential Property Fund, keeping the same entity name and under the same ASX Code 'URF'.

It is anticipated that the Stapled Securities of US Masters Residential Property Fund will commence quotation on a <u>deferred settlement basis</u> at 10:09:00 am (+/- 15 seconds) AEST on Friday, 21 June 2024.

The New Trust did not raise any capital in conjunction with its listing on ASX.
