### **ASX Announcement**

### **Pre-quotation Disclosure**

The following information is provided to ASX Limited (ASX) for release to the market in connection with the admission to the official list and official quotation of fully paid ordinary shares (Shares) in Alfabs Australia Limited (ASX:AAL) (Company) pursuant to a replacement prospect lodged with the Australian Securities and Investments Commission (ASIC) and ASX on 4 June 2024 (Prospectus).

The initial public offering of Shares at an issue price of \$0.25 per Share closed on 20 June 2024 (**Offer**). The Company successfully completed the issue of 72,000,000 Shares, raising gross proceeds of \$18,000,000. Allotment of the Shares available under the Offer completed on 21 June 2024.

The Company applied for quotation of its Shares on, and admission to the official list of ASX of 29 May 2024.

Capitalised terms used but not defined in this announcement are as defined in the Prospectus.

#### **Escrow**

There are 189,213,036 Shares, representing 66.02% of the total issued capital of the Company on an undiluted basis subject to either ASX escrow and/or voluntary escrow arrangements.

ASX have determined that 166,000,039 Shares will be subject to ASX restrictions for a period of up to 24 months.

As described in section 9.9.2 of the Prospectus, a number of existing Shareholders have entered into voluntary escrow agreements under which they will be restricted from disposing of the escrowed Shares they will hold on Completion of the Offer for the relevant Escrow Period, subject to certain limited exceptions disclosed in the Prospectus. In total, 30,950,665 Shares held by existing Shareholders will be subject to these voluntary escrow arrangements. Of these shares, 7,737,666 Shares are also subject to ASX restrictions.

As such, the following shares will be subject to restrictions:
