

## **Prophecy signs Federal Government customer with Optus**

Sydney — 1 July 2024 — Business software developer Prophecy International Holdings Ltd (ASX: PRO, "Prophecy" or "the Company") is pleased to advise the Company has signed a 6-year, AU\$10.7 million contract to provide eMite powered by the newly released Integration Platform as a Service (iPaaS) offering to Optus Networks Pty Ltd (Optus) for Services Australia as part of Services Australia's migration from its legacy on-premise contact centre to a new cloud-based CXOne platform.

eMite is Prophecy's SaaS-based Customer Experience (CX) and contact (call) centre analytics platform that combines advanced analytics, data collection and correlation, KPI management and threshold alerting into a single, scalable and powerful solution.

Services Australia is one of the principal service delivery agencies of the Australian Government.

Prophecy has agreed to provide eMite to Optus for Services Australia for an initial term of 6 years with a minimum commitment of AU\$10.7 million over the contract term, \$2.1 million of which will fall in the first year.

It also marks another significant opportunity sourced under Prophecy's Master Supply Agreement (MSA) with Australian telecommunications leader Optus, announced to the ASX on 31 August 2022.

The MSA has opened significant opportunities for both parties, empowering Optus to participate in new markets and allowing Prophecy to drive strong organic growth in both upfront and recurring revenue.

"We are delighted to partner with the Optus team to continue to deliver sovereign innovation to the Australian Government. Prophecy was the joint winner of the Austrade Exporter of the Year for Advanced Technology in 2023 and its pleasing to see the Australian Government adopt home grown innovation to deliver services to citizens. Prophecy remains very well placed to penetrate more deeply into government departments, both federally in Canberra, at a state level across Australia with Optus, and on a broader scale into state and federal governments internationally."
