BNYMC Group's power to vote or dispose of these securities is qualified accordingly.
- *Note 2: Each Group Entity is a direct or indirect wholly owned subsidiary of BNYMC, the ultimate parent company. Other than BNYM in respect of 225,618,979 securities (of which BNYM's power to only dispose of 225,618,979 securities is limited see Note 1), BNYM in respect of 52,000 securities and Pershing LLC in respect of 90 securities, none of the BNYMC Group entities are entitled to be registered as holder of the securities and their power to vote or dispose of the securities is qualified accordingly.
