Cleansing Notice under section 708A(5)(e) of the Corporations Act

SenSen Networks Limited (ASX: SNS) ("**SenSen**" or the "**Company**") gives this notice under section 708AA(10) of the *Corporations Act 2001* (Cth) (**Corporations Act**) and section 708A(5)(e) of the Corporations Act.

On 3 July 2024, SenSen issued 1,078,416 fully paid ordinary shares (**Shares**) in the capital of the Company, under the SenSen Salary Sacrifice Plan, as approved by shareholders at the Company's Annual General Meeting on 28 November 2023.

Under the Salary Sacrifice Plan, senior staff members will receive ordinary shares in SenSen in lieu of that component of their salary calculated on a 20-day volume weighted average price. It is anticipated that such Shares will be issued monthly, but always subject to the SenSen Securities Trading Policy.

The Salary Sacrifice Plan ended on 30 June 2024, therefore this share issue will be the final share issue under this plan.
