# Extraordinary General Meeting Voting Results

In accordance with Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), Regal Partners Limited (ASX:RPL) advises that the resolutions put to the Extraordinary General Meeting held today were passed on a poll by the requisite majorities.

The resolutions provided shareholder approval for the issuance of fully paid ordinary shares and unlisted options in RPL as part consideration for, and in connection with, the acquisition of JRJJ Capital Pty Limited (the head entity of the business trading as 'Merricks Capital') (the "Transaction"). Further information about Merricks Capital and the Transaction is set out in RPL's announcements to the ASX on 3 June 2024.

It is anticipated that the Transaction will complete this coming Wednesday, 10 July 2024.
