## **SEVEN GROUP DECLARES 30CPS FY24 FINAL DIVIDEND**

Seven Group Holdings (SGH, ASX:SVW) has today declared a final ordinary dividend of 30 cents per share fully franked. The dividend reflects a 30 per cent increase on the prior comparative period, and results in total dividends payable on ordinary shares for the year ended 30 June 2024 of 53 cents per share.

The dividend is declared with an ex-dividend date of 19 August 2024 and will be paid to all shareholders of record as of 20 August 2024 on 2 September 2024.

This 30 cents per share fully franked FY24 Final Dividend satisfies the commitment made by SGH to pay a post-transaction dividend, as per section 4.2 of the 4<sup>th</sup> Bidder's Statement, announced to market on 12 April 2024.
