FAR EAST GOLD APPOINTS NEW CHAIRMAN

Far East Gold Ltd ('FEG' or 'the Company') is pleased to announce the appointment of Mr. Justin Werner as Non-Executive Chairman of the Company with immediate effect. Justin is a co-founder of the Company and has been a Non-Executive Director with the Company since its inception and has been involved in the Indonesian mining industry for over 20 years with a strong track record of resource discovery and mine development.

As Managing Director of Nickel Industries' (ASX:NIC) Justin has been instrumental in leading the company to become the world's largest pure listed nickel producer in a little over 5 years since listing in 2018 with a AU\$4bn market capitalization.
