ASX: AND 16 July 2024

Transaction Update

Ansarada Group Limited (ASX:AND) ('**Ansarada**' or '**Company**') refers to the proposed acquisition by DS Answer Pty Ltd ('**Datasite**')¹, an entity owned by funds managed by CapVest, of 100% of the shares on issue in Ansarada by way of a scheme of arrangement ('**Scheme**'), and its announcement on 7 June 2024 regarding indicative timing for implementation of the Scheme.

ACCC Update

Ansarada notes the ACCC has announced a revised provisional date for the announcement of its findings on the Scheme to 8 August 2024 (and has updated its public register to that effect). If the ACCC confirms it has no objections to the Scheme, Ansarada expects FIRB approval will follow shortly afterward.

Scheme Timetable

The New South Wales Supreme Court ('Court') has made orders to:

- schedule the Scheme Meeting for Wednesday, 21 August 2024 commencing at 4.00pm (Sydney time) or as soon
 as reasonably practicable after the conclusion or adjournment of the General Meeting (whichever time is later);
 and
- adjourn the Second Court Date to 9.15am (Sydney time) on Tuesday, 27 August 2024.

Ansarada advises that the Board has resolved to schedule the General Meeting for Wednesday, 21 August 2024 at 3.00pm (Sydney time).

Ansarada Directors' recommendation

Ansarada's Independent Directors, Mr Peter James, Mr David Pullini, Ms Nancy Hobhouse and Mr Stuart Clout continue to recommend that Ansarada shareholders:²

- vote in favour of the Scheme, in the absence of a Superior Proposal and subject to the Independent Expert continuing to conclude that the Scheme is in the best interests of the Ansarada Shareholders; and
- vote in favour of the Carve-Out Transaction, subject to the Independent Expert continuing to conclude that the Carve-Out Transaction is not fair but reasonable to Ansarada Shareholders and that the Transaction overall is in the best interests of Ansarada Shareholders.

Subject to the same qualifications, each Ansarada Independent Director intends to vote in favour of the Scheme and the Carve-Out Transaction, for all Ansarada Shares held or controlled by them.
