## Scheme of Arrangement becomes legally effective

**Sydney, Australia – 19 July 2024** – Altium Limited (**ASX: ALU**) (“**Altium**”) confirms that it has lodged an office copy of the orders made by the Supreme Court of New South Wales (“**Court**”) approving the proposed acquisition of Altium by Renesas Electronics NSW Pty Ltd, an indirect wholly owned subsidiary of Renesas Electronics Corporation (TSE: 6723) (“**Renesas**”) by way of a scheme of arrangement (“**Scheme**”), with the Australian Securities and Investments Commission (“**ASIC**”) pursuant to sub-section 411(10) of the Corporations Act 2001 (Cth).

The Scheme is now legally effective, and quotation of Altium shares on the ASX will be suspended from the close of trading today. An office copy of the Court orders lodged with ASIC is attached to this announcement.

Implementation of the Scheme will occur on 1 August 2024, at which time Altium shareholders, who own shares at 7.00pm (AEDT) on 25 July 2024 (the record date), will receive A\$68.50 for each Altium share held by them.
