

QUARTERLY ACTIVITIES REPORT

Resolution Minerals Ltd (RML or Company) (ASX: RML) provides its quarterly report for the quarter ended 30 June 2024.

During the quarter, RML completed a review of its George Uranium Project in South Australia and Carrara Range Project in the Northern Territory. The Company is very encouraged with the results from these reviews, which identified strong uranium potential in each of the projects and SEDEX potential in Carrara Range in addition to the known high grade Manganese.

The Company has appointed Stephen Balch, P.Geo., as a key technical consultant. Mr. Balch's role will be to review Resolution's existing projects and potential acquisitions and offer a technical opinion on each as well as provide recommendations on advancing Resolution's flagship property, the Allegra Nickel Project (see ASX announcement "New Nickel Project Granted" on 21/08/2023).
