Quarterly Activities Report and Appendix 4C For the Quarter Ended 30 June 2024

Pro-Pac Packaging Limited (ASX:PPG, "the Company") provides the following update on its activities for the quarter ended 30 June 2024.

Summary

- Cash flows from operating activities for the quarter represented an inflow of \$6.9 million (FY24: \$4.6 million inflow), reflective of improved working capital for the period.
- Cashflows from investing activities for the quarter of \$1.7 million outflow, included \$0.8 million for the last payment relating to the new Printing Press which is now fully operational. \$0.2 million was also paid on deposits for assets covered by the Government Grant as part of the establishment of a soft plastic film recycling plant.
- As at 30 June 2024 the Company had cash on hand of \$1.1 million and unused facilities of \$14.0 million (which includes \$7.3 million from Government Grant proceeds received to be utilised for purposes of the grant) (refer to Item 7.6).
- Revenue was \$69.1 million, was slightly higher than the previous quarter of \$68.3 million, although at a lower run rate compared to the first half of the financial year.
- The trading environment continues to be challenging, with low consumer confidence resulting in subdued volumes in our existing customer base with additional de-stocking in the lead up to 30 June.
- Our export sales to our major customer in the Middle East have materially reduced since the first half of the financial year from the continued disruption being caused by the Middle East war affecting logistics and customer sentiment.

Quarterly Activities

There were no material changes to the principal activities of the Company and its subsidiaries ("Group") for the quarter ended 30 June 2024.

Changes in key management personnel

On 30 June 2024 Jonathan Ling retired as Director and Chairman of the Company. Effective 1 July 2024 John Cerini stepped into the role of executive Board Chairman as well as his CEO existing role.

Domenic Romanelli resigned from the Company, with Patsy Ch'ng assuming the role of CFO effective 2 July 2024.

Revenue performance from continuing operations

The Group's revenue of \$69.1 million for the 3 months ending 30 June 2024 is set out below:

The Group's revenue for the 3 months to 30 June 2024 of \$69.1 million was slightly higher than the previous quarter of \$68.3 million, although at a lower run rate compared to the first half of the financial year.

The market remains soft with low consumer confidence, resulting in subdued volumes in our existing customer base with additional de-stocking in the lead up to 30 June and significantly lower export sales volumes.

Payments to related parties, and their associates for the quarter ending 30 June 2024 totalled \$2,931,893 comprising:

- Remuneration of \$385,285 paid to key management personnel, in their capacity as Directors and Executives;

<u>Appendix 4C: Item 7.6 – Details of Financing Facilities</u>

As at 30 June 2024 the Group's financing facilities comprised the A\$30.0 million debtor finance facility and A\$5.0 million bank overdraft as well as standby credit arrangements totalling A\$2.8 million.

As at 30 June 2024 the Group had drawn down A\$23.8 million (undrawn A\$14.0 million, including \$7.4 million from Government Grant proceeds received to be utilised for purposes of the grant) under these facilities.

Note A

The debtor finance facility has a committed limit to December 2025. The drawings made under the committed facility limit are however revolving in nature and accordingly, the debt of \$18.059 million outstanding under the facility at 30 June 2024 will be disclosed as a current liability. This facility will continue to be available to be redrawn, subject to eligible sale invoices being presented against the facility until December 2025. For further information refer to the Company's 30 June 2023 Annual Report.

Note B

The ANZ bank overdraft will reduce to \$4.0 million and the ANZ interchangeable letters of credit and bank guarantees to \$2.2 million on 30 September 2024.

FY24 trading update

Following a disappointing trading result and lower revenue volumes for the second half of the financial year to 30 June 2024, preliminary unaudited EBITDA (pre-AASB 16) before significant and one-off items for the FY24 year was around negative \$7.5 million.

In response, the Company commenced restructuring activities in Q4 FY24 which it expects will reduce headcount by around 10% and significantly reduce cost structures in 1HFY25.
