Application for New Service Contract for Oil and Gas Exploration in Cebu, Philippines

In 2023 Gas2Grid Limited ("Company") commenced application for a new Petroleum Service Contract for oil and gas exploration in Cebu, Philippines nominating an area of interest substantially over the same area of the former Service Contract 44 ("SC44") where the Company has conducted very significant exploration for several years in the past.

The Department of Energy in Philippines ("DOE") has given its approval for the Company to publish the application for the nominated area in local newspapers.


