Icon Energy Limited (ASX: ICN) at the end of the quarter held a cash and bank balance of \$448.747.

Presently all Directors' fees have been suspended from 1 October 2023.

There were no exploration activities during the quarter.

ATP 855

Icon Energy's application to renew ATP 855 is still under assessment by the Department of Resources (DOR).

The ASX has advised Icon that until the assessment of ATP 855 is approved then the company will remain in suspension. The ASX has advised that the company can remain in suspension until January 2026 as long as it continues to release all reporting requirements under the listing rules.

Your directors are pleased at recent reports on a more favourable outlook for gas as being needed well past 2050. This is realistic and a cheaper option to approach zero carbon emissions. While burning hydrocarbons can be stopped, we must not forget that the petroleum industry is more than a source of fuel. All of our plastics, for example, are made from oil and gas.
