QUARTERLY ACTIVITIES REPORT AND APPENDIX 4C

In accordance with ASX Listing Rule 4.7B, Vectus Biosystems Limited (Vectus or the Company) presents its June 2024 Quarterly Activities Report and Quarterly Cash Flow Report – Appendix 4C.

Commentary on Activities for June 2024 Quarter

Vectus has recently put in place an Advisory Board with input from leaders in the biotechnology and pharmaceutical arenas. As previously announced, the Company is now focusing on the commercialisation of its clinical drug VB0004, together with A32, A79, P5 and Accugen.

Vectus has expanded discussions with a number of parties, and anticipates putting in place a formal outreach programme for the purpose of licencing and partnering its key assets. As the Company's focus moves mainly to commercialisation, it is anticipated that the operating costs of Vectus will be significantly reduced. In September 2024 the Company is planning to lodge its claim for a research and development (R&D) refund from the Australian Taxation Office (ATO) for its eligible R&D expenditure for the financial year ended 30 June 2024, with an expectation that the funds will be received in October 2024.

Phase Ia/Ib Human Clinical Trials

In April 2024 Vectus announced the finalisation of its Phase Ib human clinical trial. The Phase Ib trial was entitled: "A Phase I/Ib, First-Time-in-Human, Single Centre, Double-Blind, Randomised, Placebo-Controlled, Dose Escalating Study of the Safety, Tolerability and Pharmacokinetics of Single and Repeat Doses of VB0004 Administered Orally to Healthy Volunteers; and to Patients with Mild to Moderate Hypertension with Low Cardiovascular Risk", NCT04925050. As both Phase Ia and Phase Ib trials were conducted double-blinded, the code has now been requested to be opened. Availability of the complete data set means that assessment of potential biomarkers can begin. The Company will report these results in due course. No significant adverse events were reported in the Phase Ia trials and no significant adverse events have been reported to-date from the Phase Ib trials.

Finance and Corporate

The funds expended by Vectus during the June 2024 quarter were largely in connection with the finalisation of the Phase Ia clinical trials for VB0004 and the Phase Ib work. Payments for Phase I, research, patents, staff costs and Directors' fees for the quarter amounted to \$635,000. Cash-on-hand at 30 June 2024 was \$809,000. The Company received an amount of \$1,226,000 in November 2023 as its R&D refund from the ATO for R&D expenditure for the financial year ended 30 June 2023 and an additional amount of \$290,000 was received in May 2024 for the June 2023 year. Payments to related parties during the recent quarter were the Chief Executive Officer's (CEO's) salary of \$55,000 and the Non-Executive Directors' fees of \$43,000. During the quarter, fees of \$68,000 (for corporate services, including cost re-imburement for information technology, human resources and accounting services, in line with budget) were paid to Regional Corporate Services Pty Ltd, of which Non-Executive Director Maurie Stang is a director.

About Vectus Biosystems Limited

The Company is developing a treatment for fibrosis and high blood pressure, including for three of the largest diseases in the fibrotic market, namely heart, kidney and liver diseases. Vectus successfully completed its Initial Public Offering (IPO) on the Australian Securities Exchange (ASX:VBS) and commenced trading on ASX on 23 February 2016, after raising \$5.1 million. Funds from the IPO were predominantly used to develop the Company's lead compound, VB0004, which aims to treat the hardening of functional tissue and high blood pressure. Vectus has conducted a range of successful pre-clinical trials, which have shown that VB0004 slows down the advances of fibrosis, potentially repairs damaged cell tissue and reduces high blood pressure. VB0004 is now progressing through a number of important milestones, including pharmaceutical scale-up and additional toxicity studies. Following the successful results from the 2019 fundraising via convertible notes, which were all subsequently converted into shares, and the 2020 and 2022 share placements, and share purchase plan, the Company has funding for its Human Phase Ib trial of VB0004, and to advance it and the other drugs in its library. Vectus' strategy is to develop and perform early validation of its drug candidates to the point where they may become commercially attractive to potential pharmaceutical partners.

The Company has also developed technology aimed at improving the speed and accuracy of measuring the amount of DNA and RNA in samples tested in laboratories. The technology, called Accugen, is owned by Vectus' wholly-owned subsidiary Accugen Pty Limited. The technology offers a time, cost and accuracy benefit compared to currently-available systems. The Company's current stage of investment in Accugen is a commercialisation programme that may include direct sales, distribution partnerships and licencing opportunities.

8.6.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

The level of expenditure is reducing significantly as the Phase 1b human clinical trials are now technically completed. In addition, as reported, the reduction in the Company's research and development (R&D) activities will lead to a large reduction in Vectus' cash outgoings, and therefore extending the Company's cash runway. Further, Vectus expects to receive \$858,000 in October 2024 as an R&D refund from the Australian Taxation Office for expenditure incurred on R&D during the year ended 30 June 2024.

8.6.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

The Company continues to evaluate a number of options to address its future capital requirements and is examining the opportunity for potential partners or licencees to fund further clinical studies.

8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Vectus expects to be able to continue its operations and to meet its business objectives based on its reduced overheads, pending an R&D refund and cash on hand.
