On 31 January 2024, the Company announced that it had executed binding agreements with Nebari Natural Resources Fund II LP (Nebari) on the following terms: • USD28 million (AUD\$42 million equivalent) senior secured loan facility. • Four year term. • The loan facility is in two tranches with USD18 million drawn at closing on 7 February 2024 (Tranche 1) and USD10 million available to be drawn (Tranche 2). • Tranche 2 is subject to certain conditions precedent including commencement of commercial production of sulphide ore at TNC’s Cloncurry Copper Project. • The funded amount is up to USD28 million net of the original issue discount which is 7% on both tranches. The coupon is a three-month term secured overnight financing rate (subject to a minimum of 4%) + a margin of 6.9% p.a payable quarterly (for Tranche 1) and 6.6% p.a. payable quarterly (for Tranche 2). The Company has issued 46,383,038 warrants to Nebari with an exercise price of 11.27 cents and an expiry date of 31/1/28 in consideration of the Tranche 1 drawdown. Further warrants would be issued to Nebari should Tranche 2 be drawn down on terms as outlined on Appendix 1 of the announcement made on 31 January 2024. All warrants are convertible into TNC shares. • The loan is secured by the assets of TNC.
