BARRY PARADE PROJECT

The Company continues to contemplate the feasibility of the project with cost of development being the major focus of these considerations. As previously announced on 14 June 2024, this analyse has culminated in the decision to seek expressions of interest for the project and the associated freehold land.

Expressions of interest are being sought after it It has become clear that costs associated with the projects development are unlikely to materially reduce in the short term to the levels used in the initial economic modelling for the project. Adding to this is the high level of fixed holding costs that are incurred on a month-by-month basis with no clear indication of when development may start.

No formal decision has been made on the project's future however it was deemed prudent to explore market demand for a potential sale whilst considering all options for the project.

The Company has appointed Cushman & Wakefield as its agent who are currently undertaking a marketing campaign to solicit expressions of the interest for the project. The expression of interest campaign will close on 28 August 2024.

Loan Facilities:

United Overseas Bank continues to provide a loan of \$18,800,000 for the Barry Parade Property. The loan is subjected to an interest rate of 6.4100% per annum. The loan is secured by way of first legal mortgage over the property.

Other Facilities:

Working Capital Unsecured Loan, from Khosland Management Pte Ltd (a related party)

Amount \$2.00m. The loan is repayable at call. However, undertakings have been given that the lender will endeavour to support the Company to the extent necessary to ensure that the Company will be able to continue to fund ongoing operations and meet its liabilities as and when they fall due. The loan is subjected to an interest rate of 7% per annum.

Convertible Notes

The Convertible Notes are unsecured and repayable in 60 months from the date of issue or 9 months from the date of issue if shareholder approval is not obtained to the convertibility of the Notes within three months of the date of issue. To date, the Company has not obtained shareholder approval as contemplated by the terms of the Notes and accordingly, some of the Notes have become repayable. However, the relevant Noteholders have not sought repayment to date.

The \$9,787,594 worth of Class A Notes bear interest of 9.0%, with the interest repayable quarterly.

The \$836,038 worth of Class B Notes bear interest of 13.8%, with the interest repayable with the capital at the end of the Note term.
