FY24 Q4 Quarterly Activities Report and Appendix 4C Cash Flow Statement

Brisbane, 31 July 2024: Health and Plant Protein Group Limited (ASX:HPP) (**HPP**, the **Company**) presents its Activities Report and Appendix 4C for the quarter ended 30 June 2024.

Business update

The Company ended the quarter with closing cash and cash equivalents of \$1.3 million (31 Mar 2024: \$1.9 million). Appendix 4C as attached forms part of this announcement. The amount of \$12,000 under item 6.1 relates to remuneration of non-executive directors.

Cash outflows during the quarter included \$300,000 for the 7,142,857 shares cancelled under the equal access off-market share buy-back that the Company undertook during the previous quarter.

As previously disclosed, HPP is awaiting the repayment of the balance of the sale proceeds which is currently being held by the US Internal Revenue Service (**IRS**) pending finalisation of the US withholding tax payable by HPP in respect of the sale of the macadamia division in April 2023.
