The Company has a loan facility available to it provided by Bizzell Nominees Pty Ltd an entity associated with the Company's Chairman. The facility is for up to \$6.5 million, interest rate on drawings is 8%, is repayable on 31 December 2024 and the facility is unsecured. As at 30 June 2024 the facility has been drawn to \$2,186,751.

The Company has a short term loan facility provided by Norfolk Enchants Pty Ltd, an unrelated third party. The facility principal is for up to \$6m, has an interest rate of 20% per annum and is repayable on 31 October 2024. The facility is secured by a fixed and floating charge over the assets of the Company. As at 30 June 2024 the facility had been drawn to \$5,750,000.

The Company has a loan facility available to it provided by Nambia Pty Ltd an entity associated with NED Mr R Anthon. The facility is for up to \$0.5 million, interest rate on drawings is 15%, was repayable on 30 July 2024 and the facility is unsecured. As at 30 June 2024 the facility has been drawn to \$500,000.
