**Re: Notice of Change in Substantial Shareholding in BSP Financial Group Limited (ASX: BFL | PNGX: BSP)**

FNPf recently acquired an additional 5,007,433 fully paid ordinary shares in BSP Financial Group Limited (ASX: BFL | PNGX: BSP) (**BSP**) by way of a number of trades conducted off-market.

FNPf is a substantial shareholder in BSP, being the holder of 9.85% of BSP shares as at 30<sup>th</sup> June 2023. The acquisition of additional shares in multiple parcels will increase its shareholding in BSP by 1.08%, reaching an aggregate shareholding of 10.93%.
