ADDENDUM TO ANNOUNCEMENT

The Directors of Far East Gold (ASX:FEG) (**FEG** or the **Company**) at the request of the ASX, provide the following additional information to the FEG Announcement released 15 August 2024 (the **Announcement**) regarding the preparation of a 2012 JORC Resource for PT Iriana Mutiara Idenburg gold concession (Idenburg).

In relation to the Exploration Targets referred to in the second paragraph on p.1 of the Announcement, and the last dot point on p.1 of the Announcement, the SMGC independent evaluation of the historical exploration results suggests the potential for an upper range exploration target of 7.2 million ounces at an upper grade range of 6.1g/t Au. A lower range exploration target of 189 thousand ounces at 1 g/t Au was also determined. Refer to the independent SMG Consultants (SMGC) report titled 'Pt. Iriana Mutiara Idenburg Exploration Targeting Report June 2024 attached to the Announcement.'

The potential quantity and grade of the Gold Exploration Targets are conceptual in nature. There has been insufficient exploration to estimate a Mineral Resource under the 2012 JORC Code and it is uncertain if further exploration will result in the estimation of a Mineral Resource.
