Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

This notice is given by Auswide Bank Ltd (ACN 087 652 060) (ASX Code: ABA) (**Auswide**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

Auswide refers to its announcement on 19 August 2024 relating to its entry into a binding agreement to acquire 100% of Specialist Equipment Leasing Finance Company Pty Ltd (**Selfco**).

Auswide has today issued 1,174,847 fully paid ordinary shares (**New Shares**) to the vendors of Selfco in consideration for 100% of the shares in Selfco.

Auswide gives notice under section 708A(5)(e) of the Corporations Act that:

- (a) Auswide issued the New Shares without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) as at the date of this notice, Auswide has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to Auswide; and
 - (ii) section 674 and 674A of the Corporations Act, as they apply to Auswide; and
- (c) as at the date of this notice, there is no excluded information of the type referred to in sections 708A(7) and 708A(8) of the Corporations Act that is required to be set out in this notice under section 708A(6)(e) of the Corporations Act.


