Correction Notice: Withdrawal of Notice of Initial Substantial Holder Notice and Change of Substantial Holder Interests Notices for News Corporation

On 14 July 2022, UniSuper Limited as trustee for UniSuper and UniSuper Management Pty Ltd (together referred to as 'UniSuper') filed a Notice of Initial Substantial Holder ('Form 603') for News Corporation Class B ('First Notice').
