

## **RESULTS OF 2024 SEPTEMBER EGM**

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act, Thrive Tribe Technologies Limited (ASX:1TT, Thrive Tribe or Company) is pleased to advise the results of its 24 September 2024 Extraordinary General Meeting held today.

Resolutions 1, 2 and 4 were put to shareholders, were decided by poll and have passed. The resolutions presented for shareholder consideration and the total number of votes cast in respect of each resolution are set out in the attached report from the share registry, Boardroom. Resolution 3 was withdrawn as the proposed placement announcement on 25 July 2024 will not be proceeding. Having received the R&D Grant the Company made the commercial decision not to cause further dilution to existing shareholders. The company will not be issuing options as per Resolution 4 as Resolution 3 did not proceed.


