The acquisition will be part funded by the issue of MYR50,000 worth of CHESS Depositary Interests (CDIs) subject to the achievement of conditions before 31 May 2027. Each CDIs will be valued at the 14-day volume-weighted average price (VWAP) prior to the issue.

The acquisition enables the Group to achieve full control of XT to accelerate the development of both the Xamble Creators platform and Xamble Social Wallet utilizing the Grant.
