On 2 October, EPX entered into a binding agreement with the Coda Cloud Limited. EPX acquired the assets and business for an upfront consideration and two Contingent Performance based payments. It is assumed that these shares will be issued if recurring revenues 12 months from completion reach in-excess £500,000 from one specific customer. If achieved, the exact number of shares will be based on the 20-day VWAP at that point in time.
