Perpetual 2024 AGM: Summary of meeting format

Perpetual Limited's (**Perpetual** or **Company**) 2024 Annual General Meeting (**AGM**) will be held on **Thursday, 17 October 2024 at 10.00 am**.

The AGM will be held at the Swissôtel Sydney, Level 8, 68 Market Street, Sydney NSW, 2000, in the Blaxland Ballroom, as well as facilitated using a virtual online platform.

Shareholders using the virtual online platform will have the ability to vote and ask questions on each resolution and submit votes in real time.

An additional Web Phone facility will also be provided for shareholders to ask questions orally if joining the meeting virtually.

Perpetual confirms to shareholders that the AGM on Thursday, 17 October 2024 at 10.00 am (Sydney time) will be held both physically at the Swissôtel Sydney, Level 8, 68 Market Street, Sydney, in the Blaxland Ballroom, and as a virtual meeting.

Shareholders will be able to attend physically or join and participate in the AGM through the online platform. Following is a guide, in question-and-answer format, to assist you.

Shareholders should monitor Perpetual's website and ASX announcements where updates will be provided if it becomes necessary or appropriate to make alternative arrangements for the holding or conduct of the AGM.

What do I need to do before the day of the meeting if I wish to participate online?

Please take time to read the Virtual Meeting Online Guide (**Online Guide**) before the day of the meeting at perpetual.com.au/shareholders/annual-general-meeting

The first step highlighted in the Online Guide is to confirm your browser is compatible.

This Online Guide explains the platform we will use for the meeting and how you can take certain actions (including voting and asking questions during the meeting) through that platform. Please read through it carefully prior to the meeting.

Please also have your SRN or HIN information for your securities. Your SRN or HIN is noted on the documentation previously sent to you such as a holding statement, CHESS statement or dividend statement.

If I do not wish to attend the meeting either in person or virtually, can I vote by proxy?

Yes, you can vote by proxy. The process to appoint proxies is set out in the Notice of Meeting. You need to lodge proxies no later than **10.00 am (Sydney Time) on Tuesday, 15 October 2024**.

To obtain a copy of the proxy form you can:

- click the link perpetual.com.au/shareholders/annual-general-meeting and follow the instructions for submitting; or

- obtain a proxy form by calling Link Market Services +61 1300 732 806 and they will send you a proxy form.

Even if you plan to attend in person or participate in the AGM online, we encourage you to submit a directed proxy vote so that your vote will be counted if for any reason you cannot vote on the day.

What is the platform we will use for the virtual meeting if I would like to participate?

The platform will be available through this link: <https://meetings.linkgroup.com/ppt24>. This platform will be live at 9.30 am on the morning of the AGM. You can then log in any time after it is live until the Chairman closes the voting at the end of the meeting.

How do I vote online?

When you log into the platform, you will be required to register as a shareholder or proxy holder and vote your shares or the shares you represent as proxy. This will be done by selecting the appropriate option 'For' – 'Against' – 'Abstain' and clicking the 'Submit Vote' button. The facility enables you to split votes if you hold different proxies.

At the meeting the Chairman will explain the voting procedure as each resolution comes up for voting.

As a shareholder, how do I ask a question or make a comment at or before the AGM online?

The Chairman will call for questions and comments at the AGM. You will be able to ask a question either by submitting a written question or asking a question verbally via a moderated teleconference. Instructions for either option are outlined below:

- **Written questions or comments at the AGM.** You can submit questions in writing through the platform. You can do this from 9.30 am onwards on the day of the AGM until the close of voting at the end of the AGM.

There will be a box on the platform which you can click on and type in your question or comment. The questions are to be between 24 and 512 characters long. These will be processed by the Company Secretary or other officer of the company and the question will be read to all participants and a response given by the Chairman or a representative designated by the Chairman. The meeting will also be advised of the name of the shareholder asking the question.

- **Audio questions or comments at the AGM.** Through the platform, you can ask an audio question. Please mute the webcast meeting and then go the Web Phone and type your name and hit the green call button. Then start your call and you will be in the meeting on mute. When the Chairman asks for questions, press*1 on the keypad on your screen for the item that your question or comments relate to. When it's your turn to speak, the moderator will introduce you and your line will be unmuted. You will be prompted to speak. Your line will be muted once your question has been asked.
- **For written questions or comments before the AGM.** You can still submit written questions prior to the AGM whether or not you then attend the AGM. You can do so in one of three ways:

1. Through the registry service provider voting page as follows:

- click the link investorcentre.linkgroup.com;
- enter Perpetual or PPT, your SRN/HIN, postcode and the randomly generated Security Code; and
- you will then need to click on 'Voting' at the top of the page which will take you to the online voting page where you can type your question; or

2. By using the shareholder question form:

- click this link perpetual.com.au/shareholders/annual-general-meeting and follow the instructions for submitting; or

3. By calling Link Market Services +61 1300 732 806 and they will send you a shareholder question form.

Questions submitted in this way must be received by no later than **5.00 pm (Sydney Time) on Thursday, 10 October 2024.**

Attendance in person

On the day of the AGM, shareholders attending in person will receive a voting card from Link Market Services. They will be used to cast your votes and will be collected before you leave the AGM. There will be an opportunity to ask questions in the room.
