Expiry of Listed Options (ASX: EGYO)

Energy Technologies Limited (ASX: EGY) (or the “**Company**”) advises that 25,000,058 quoted options, exercisable at \$0.20 each (trading under ASX code EGYO) (**Options**) will expire at 5pm (AEST) on 31 October 2024 (**Expiry Date**).

Official quotation of the Options on ASX will cease at close of trading on Friday, 25 October 2024, being four business days before the Expiry Date.

The Company notes that the Options are substantially “out of the money” and advises that it will not be dispatching personalised notices to option holders in accordance with Item 5.3 of Appendix 6A to the Listing Rules.

In accordance with Item 5.2 of Appendix 6A, the Company provides the following information to holders of the Options:

- 1) the total number of Options on issue is 25,000,058;
- 2) the number of fully paid ordinary shares in the Company to be issued on the exercise and conversion of the Options is 25,000,058;
- 3) the exercise price for each Option is \$0.20;
- 4) the due date for payment of the exercise price (in cleared funds) is the Expiry Date;
- 5) if payment in cleared funds is not received by the Expiry Date, the Options will expire unexercised and all rights attaching to the Options will cease;
- 6) official quotation of the Options on ASX will cease at close of trading on Friday, 25 October 2024, being four business days before the Expiry Date;
- 7) the market price of the Company’s shares at the close of trading on Monday, 21 October 2024 was \$0.03, being the latest available market price of the Company’s shares on ASX prior to the date of this announcement;
- 8) during the three months preceding the date of this announcement:
 - i. the highest market price of the Company’s shares on ASX was \$0.0371 from 22 July to 25 July 2024; and
 - ii. the lowest market price of the Company’s shares on ASX was \$0.029 from 18 October to 18 October 2024; and
- 9) as at the date of this announcement, there are no underwriting agreements in relation to the Options.
