- Approaching EBITDA positive for September Quarter @ (\$0.2m), incl. \$0.2m investment in IBC Trade Show



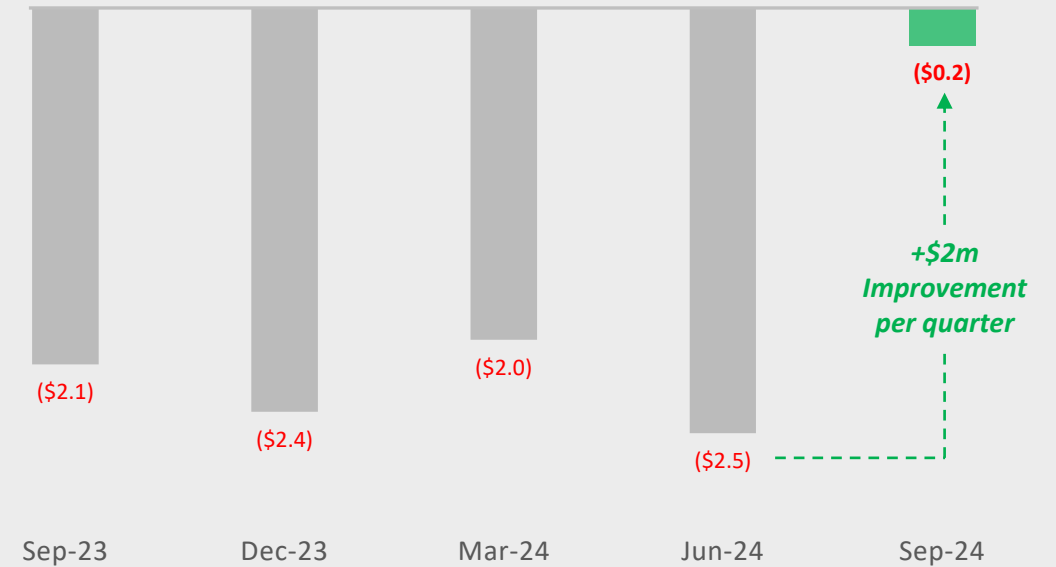
BIRDDOG 2.0 INFLEXION POINT.

Average quarterly EBITDA loss of \$2.3m during FY24 (~\$9m annual EBITDA loss, excl. litigation & ancillary fees of \$2.6m).

Delivered a \$2m+ improvement in quarterly profitability for the September '24 quarter.

September quarter EBITDA loss of \$0.2m included a \$0.2m investment at the IBC Trade Show in mid-September, launching new products and heralding BirdDog 2.0 with a full suite of next generation products.
