<i>In December 2022, wholly owned subsidiary Atcor Medical Pty Ltd entered into a short-term working capital loan facility for up to \$880,000, to support product and development expansion initiatives. Key terms of the facility, which was extended during the quarter are:</i> • <i>Extended expiry of facility: 30/11/24;</i> • <i>Facility limit: \$880,000;</i> <i>Interest rate: 1.33% per calendar month (16%p.a).</i>			
<i>On 8 November 2023, the Company announced that it had entered into a Funding Commitment Agreement (FCA) with its largest shareholder C2 Ventures (C2V), which is controlled by executive directors, Niall Cairns and Craig Cooper. The FCA provides an additional \$6 million in funding to the Company in 2024, and further supports the Capital Raising Package that includes the Placement and Entitlement Offer that were completed in February, and which C2V contributed \$2.4 million. The \$6 million FCA may be drawdown by the Company, or invested by C2V, and shareholder approval for its conversion will be sought at an Extraordinary General Meeting that is scheduled on or around 24 May 2024. As of 30 September 2024, \$2.25m has been drawn on the facility.</i>			
<i>As announced on 20 November 2023, the Company agreed a Promissory Note with its US legal counsel, Wilson Sonsini Goodrick & Rosati, Professional Corporation (WSGR) for US\$1,500,000 (A\$2.26m) for the agreed reduced amount of US legal fees outstanding from the Company’s withdrawn NASDAQ IPO and capital raising initiative. The key terms of the Promissory Note are:</i> • <i>5.5% interest rate</i> • <i>Repayment terms (per amendment agreement in September 2024)</i> - <i>US\$250k before 31 January 2025.</i> - <i>US\$250k before 31 July 2025.</i> - <i>The final balance of US\$1m plus interest repayable by 31 October 2025.</i>			
<i>On 9 August 2024, the Company entered into a new R&D Term Loan Facility of \$1,120,000 with Mitchell Asset Management Pty Ltd (“MAM”), which was advanced as a prepayment of forecast Research and Development Tax Incentives that are anticipated to be receipted by the Company for the 30 June 2024 and 30 June 2025 financial years. The facility attracts interest at 18% per annum. \$600,000 of the principal is due upon receipt of the 2024 R&D Tax Incentive Refund (with an extended due date of 30 November 2024), with the balance secured by the 2025 R&D Tax Incentive Refund due by 31 October 2025.</i>

Sales from the CONNEQT Pulse device are expected in Q2 of FY2025, and the waitlist for the device has surpassed 20,000 preregistered customers. Preliminary discussions have taken place with various debt funders and equity providers both in Australia and the US, which may be required to progress further should sales of the CONNEQT Pulse be lower than anticipated, or if there are delays to clinical trial cash flows that are expected to arise from the current sales pipeline.

Post quarter end, the Company was selected as one of five grand prize winners in the final phase of the National Institutes of Health's Rapid Acceleration of Diagnostics (RADx®) Tech for Maternal Health Challenge, resulting in a further US\$525k in cash grant funding, which is expected to be received in Q2 of FY2025.

During the quarter, Cardiex received approval from AusIndustry for the inclusion of overseas software development costs in its R&D Tax Incentive claims for FY2024-FY2026 and is anticipating a refund of \$1.4 million in Q2 of FY2025, a significant increase from prior year claims. This is secured against Cardiex's R&D funding facility with Mitchell Asset Management, and the Group may consider extending this facility against the following years R&D claim.

Based on all the above, the Directors are of the opinion that it will continue to obtain sufficient ongoing working capital requirements.
