

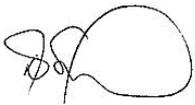

## Auswide Bank Ltd (ABA) Results of 2024 Annual General Meeting

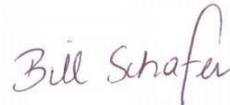
