All Resolutions were carried by a poll.

In relation to Resolution 1 "Adoption Remuneration Report", with key management persons excluded from voting, 57.97% voted for this resolution and 42.03% against.

As more than 25% of the votes were cast against Resolution 1, this constitutes a "first strike" for the purposes of the *Corporations Act 2001* (Cth).
