

## Entitlement Offer to raise up to A\$703,000

Thrive Tribe Technologies Limited (ASX:1TT) (**1TT** or **Company**) is pleased to announce that the Company will undertake a non-renounceable pro-rata entitlement offer to eligible existing shareholders (**Offer**).

The Offer is being made under an offer booklet (Offer Booklet).

# Key terms of the Offer

The Offer will provide eligible 1TT shareholders the opportunity to apply for one (1) new fully paid ordinary share (New Shares) for every one (1) existing fully paid ordinary share (Shares) held as at 7.00pm (Sydney time) on 4 December 2024 (Record Date), at an offer price of \$0.001 per New Share (Offer Price). It is anticipated that up to 703,000,000 New Shares may be issued pursuant to the Offer, which would raise approximately \$703,000 before expenses of the Offer. The Offer is not underwritten.

The Company will use the proceeds raised under the Offer to fund the costs of the Offer and to provide working capital to the Company generally.

The Offer price represents a 33% discount to the closing price of Shares on 27 November 2024, the last trading day before this announcement.

The Offer is open to 1TT shareholders with registered addresses in Australia, New Zealand and Malaysia as at the Record Date. Shareholders at the Record Date with a registered address outside Australia, New Zealand and Malaysia will not be eligible to participate in the Offer. Existing holders of options will not be able to participate in the Offer unless they exercise their options and become a registered holder of Shares (upon exercising their options) prior to the Record Date.

The Offer will include a top-up facility that allows eligible shareholders to apply for additional New Shares in excess of their entitlements, to the extent that there is a sufficient amount of New Shares not taken up by other eligible shareholders, at the same issue price as the Offer.

The New Shares issued pursuant to the Offer will rank equally with the existing issued Shares of the Company and are expected to be quoted on the ASX.
