Equity markets around the world had a wide range of reactions to the election of Donald Trump in November. US markets rallied strongly, with the S&P500 up +5.7%, NASDAQ up +6.2% and Russell 2000 Small Cap Index up +10.8%, whereas Asian markets fell heavily with the Hang Seng down -4.4%, KOSPI down -3.9% and Nikkei down -2.2%. Unfortunately, this had a negative impact on the VG1 portfolio (down -7.5%)², both from some of the Asian long positions and US equity shorts.

Some longs like Amazon (+12%), LSEG (+7%) and Flutter (+19%) were all positively impacted by the market rally and improving fundamentals.

On the other hand, it remains a difficult shorting environment. Unprofitable shorts were up very strongly. The portfolio has closed the majority of these short positions.

Resources stocks underperformed on a lack of detail in Chinese stimulus measures. We remain of the view that global resources stocks are cheap and under-owned, setting up for what we consider will be a stronger 2025.

Buy-back: In November, approximately 6.0m VG1 shares were bought at an average price of \$1.93.
