Enclosed is a copy of a Form 604 Notice of change of interests of substantial shareholder in relation to Bravura Solutions Limited (BVS) completed by Stichting Bewaarder GFC (Stichting), the depository of mutual fund Gran Fondo Capital (the Fund).

The change in interests arose as a result of an internal reorganisation which occurred on 17 December 2024, pursuant to which Stichting's wholly owned subsidiary Gran Fondo Capital B.V. transferred its beneficial interest in the shares in BVS (the Shares) to a new corporate entity GFC Bravura B.V. (which is owned jointly by Gran Fondo Capital B.V. and an entity controlled by the director of Gran Fondo Capital's fund manager).

Following the internal reorganisation, Gran Fondo Capital B.V. continues to have a relevant interest in the Shares. Strikze B.V. and Tjitske Strikwerda also obtained a relevant interest in the Shares as a result of the reorganisation. There is ultimately no change to voting power.

Additionally, on 15 March 2024 Gran Fondo Capital B.V. sold 2.700.000 shares in Bravura. This was not previously reported as this represented a sub-1% movement in voting power from the Form 604 dated 29 February 2024.
